The Pike County Board of Commissioners met with Mark Flint, Ryan Coleman and Jeff Nelson present. Also in attendance were Val Fleig, Judy Gumbel, Kristi Dischinger, Josh Byrd, Roger Ham, David Capehart, Chris Young, Kent Johnson, Ryan Benner, and Andy Heuring.

Auditor Judith Gumbel called this, the first Commissioners' Meeting of 2020, to order. Election of Officers for 2020 was the first item on the agenda.
