~~Amended~~ RESOLUTION OF THE PIKE COUNTY COUNCIL OF PIKE COUNTY, INDIANA

A RESOLUTION AUTHORIZING AND PERMITTING DISBURSEMENTS FROM THE PIKE COUNTY SHERIFF'S COMMISSARY FUND AS ALLOWED BY INDIANA CODE 36-8-10-21

BE IT HEREBY RESOLVED BY THE COUNCIL OF PIKE COUNTY, INDIANA THAT:

WHEREAS, the Pike County Council is the fiscal body of Pike County, Indiana:

WHEREAS, I.C. 36-8-10-21 provides for the establishment of a Commissary Fund into which funds from Commissaries at the Pike County Jail shall be deposited and from which the Sheriff or his designee may expend funds for those items enumerated in I.C. 36-8-10-21 including items which benefit the Sheriff's Office as are mutually agreed upon between the Sheriff and the Pike County Council pursuant to I.C. 36-8-10-21 (d); and

WHEREAS, Indiana Code 36-9-10-21 (d) permits the money in said Commissary Fund to be used as follows, to-wit:

- (1) merchandise for resale to inmates through the commissary;
- (2) expenses of operating the commissary, including, but not limited to, facilities and personnel;
- (3) special training in law enforcement for employees of the sheriff's department;
- (4) equipment installed in the county jail;
- (5) equipment, including vehicles and computers, computer software, communication devices, office machinery and furnishings, cameras and photographic equipment, animals, animal training, holding and feeding equipment and supplies, or attire used by an employee of the sheriff's department in the course of the employee's official duties;
- (6) an activity provided to maintain order and discipline among the inmates of the county jail;
- (7) an activity or program of the sheriff's department intended to reduce or prevent occurrences of criminal activity, including the following:
 - (A) Substance abuse.
 - (B) Child abuse.
 - (C) Domestic violence.
 - (D) Drinking and driving.
 - (E) Juvenile delinquency;
- (8) expenses related to the establishment, operation, or maintenance of the sex and violent offender registry web site under IC 36-2-13-5.5; or
- (9) any other purpose that benefits the sheriff's department that is mutually agreed upon by the county fiscal body and the county sheriff.
 - (A) Reimbursement for investigation expenses;
 - (B) Reimbursement for damaged employee property;
 - (C) Matching funds for grants;

- (D) Expenses for Contracting with Professional consultants;
- (E) Expenses associated with rental/purchase of specialized equipment, including vehicles to be utilized by the Sheriff's Office;
- (F) Expenses associated with special events for inmates or employees such as Holiday Events, Retirement events, Recognition events, etc.;
- (G) Expenses regarding special details, investigations;
- (H) Any purpose that benefits the Sheriff's Office that does not exceed \$2,000; and
- (I) All forms of Training & Conferences associated with the duties of the Sheriff's Office

Money disbursed from the fund under this subsection must be supplemental or in addition to, rather than a replacement for, regular appropriations made to carry out the purposes listed in subdivisions (1) through (9).

WHEREAS, the Pike County Council has determined that it is in the best interest of the County to allow the Pike County Sheriff's Office to make these disbursements from the Commissary Fund.

NOW, THEREFORE, BE IT RESOLVED BY THE PIKE COUNTY COUNCIL THAT;


