After hearing all bids, Commissioner Flint stated that the bids will be taken under consideration.

Pike County/City of Petersburg Interlocal Agreement

President Flint explained that this is a proposed amended agreement between the County and the City of Petersburg for an extension for Payment of \$857,000 Grant from the County to the City for construction of a Waterline and Infrastructure in regard to the remaining balance of \$343, 843.39. The agreement remits said balance to City prior to the end of 2020 with any funds which would remain at the project end to be returned to the County by the City. This amendment has already been approved by the Pike County Council.

Commissioner Coleman seconded by Commissioner Nelson motioned to approve the amendment. Motion passed 3-0.

Employee Holiday Policy

Commissioner's Assistant Kristi Dischinger requested that the Board of Commissioners approve the following addition to the Employee Holiday Policy:

A <u>Permanent Part Time Employee's</u> work history must show that 75% of the particular day corresponding to the holiday must have been worked over the previous 3 months to be eligible for holiday pay. For example, if the holiday falls on a Thursday, the employee's work history must show they have worked 75% of all Thursdays in the prior 3 months.

After discussing the policy addition, Commissioner Flint called for a motion.

Commissioner Nelson seconded by Commissioner Coleman motioned to approve the addition to the Employee Holiday Policy as presented. Motion passed 3-0.

The Commissioners discussed these items as a whole. The contracts are 4-year agreements with a 60-day notice of cancelation required. Malcon calculates reimbursements due the County for services provided for the IV-D population in the agreements for the Prosecutor and Circuit Court. The Fuel Tax agreement is regarding reimbursement to the County for any eligible fuel tax expense incurred by the County Highway, EMS, and Assessor. The latter agreement requires the POA.

Per Malcon since 2018 thru August of 2020 the following amounts have been recovered: \$39,066.68 – Pike Clerk IV-D. \$42,151.99 – Pike Court IV-D. \$293,282.26 – Pike Prosecutor IV-D

\$10,583.69 - Fuel Tax Refund

EMS Director Chris Young stated that while his contract with Malcon was not being considered, his department had recovered in excess of \$260,000 from Medicaid since the beginning of the County EMS/Malcon agreement. He stated that one of the values of the service was that Malcon represented the County during an audit and should there be a finding it was the responsibility of Malcon.

Auditor Gumbel shared that the County has paid Malcon a total of \$90,952.00 for their services over this period of time.

Commissioner Coleman seconded by Commissioner Nelson motioned to renew the contracts. Motion passed 3 - 0.

Commissioner Coleman seconded by Commissioner Nelson moved to accept the Meeting Schedule as presented. Motion passed 3-0.

Commissioners' Transfer

\$400.00 from 1000-030-03-3017, Contract Computer Backup, to 1000-030-03-3084, County Owned Land Expense

Ms. Dischinger explained that the transfer was needed because the wet spring required that more mowing be done.

Commissioner Flint asked if there were any questions.

Commissioner Nelson seconded by Commissioner Coleman moved to approve the transfer. Motion passed 3 - 0.

Courthouse Status-COVID

County Health Nurse Amy Gladish stated there were 454 cumulative number of COVID cases in Pike County. She said that 60 to 80 cases per week are active. The Governor issued a new Executive Order 20-48 limiting the size of gatherings to 50 if the County was at the orange level moving to gatherings of 25 at the red level. For sporting events the schools are allowed a crowd capacity of 25%, but if the County moves to red only parents and siblings may attend the events. The Health Department must approve the plan for any Social Gatherings with over 50 in attendance. Churches are exempt for church services but weddings, congregation dinners etc must have the plan approved. She also stated that information regarding a vaccine was

favorable. She stated that initially the vaccines would be available to front-line workers.

Pike County COVID Testing Site Coordinator Pamela Cosby reported that things were running pretty smoothly and were testing from 75 to 100 persons per week.

EMS Director Chris Young said that they are continuing to transport COVID patients.

Recognition of Retiring County Superintendent, Roger Ham

Commissioner Flint recognized Roger Ham for his 47 years and 11 months of service to the County. He stated that not many people were able to say that they had worked for the same company for such a long period. Others joined in the accolades: Commissioners Nelson and Coleman, County Attorney Val Fleig, and County Road Superintendent Josh Byrd.

REGARDING BUSINESS BY PUBLIC

Pamela Cosby stated that she was going to be requesting some cell phones for use by the COVID Testing Center Personnel. She also stated that she needs to upgrade her signage a little bit. Josh Byrd stated that he would see what he could do to help her.

Hearing no further requests, Commissioner Flint called for a motion to adjourn.

Commissioner Coleman seconded by Commissioner Nelson moved to adjourn. Motion passed 3-0.
