#### **INDOT Unofficial Detour**

A Memorandum of Understanding regarding an Unofficial Detour on Local Roads for HMA Overlay and Pavement Replacement State Road 61, specifically between Jct. 61/56/57 to 1.1 mile N of S.R. 61 was discussed. The detour includes the County's portion of White River Ave. and Harvest Lane and is in accordance with IC 8 -23-21. State Route 61 will be closed by INDOT for about 180 days. INDOT will handle the traffic control for official Detour route. INDOT will reimburse County for costs related to damage repair on the listed Unofficial Detour as mutually agreed. INDOT and County must execute an agreement stating the costs when the official INDOT Detour is eliminated. Highway Superintendent Byrd stated that yards are definitely getting torn up. He stated there is a 50' right of way. County has been fining trucks that are causing the damage.

Commissioner Coleman seconded by Commissioner Nelson made motion to approve the Memorandum of Understanding. Motion passed 3-0.

#### Grow SW Indiana (LEO)

Sara Worstell, Executive Director Grow SW Indiana Workforce Board presented a Local Elected Officials' Agreement for the Commissioners' consideration. The agreement is in regard to the Workforce Innovation & Opportunity Act and is in regard to Region 11. Their request is that Pike County select a County Chief Elected Official to Represent the County on the local Workforce Investment Board. The duties of the position were designated. The period of the Agreement is from July 1, 2022 through June 30, 2024, and is amendable.

Commissioner Nelson seconded by Commissioner Coleman nominated Commissioner Coleman to continue as Pike County's Representative. Motion passed 3-0.
