5. Dave Henson / Proposal for New Shelter House

The proposal for shelter house#1 was discussed and a decision was reached. The RFPQ committee made a recommendation to the Park Board to accept the proposal received from GM Development Companies LLC as the developer for the Project. The Park Board, on a vote of 5 in favor and 0 against was made. One member was absent but she stated that she was also in favor of the Project. Chairman Hollis turned in an additional appropriation for \$233,000.00 to complete the project. This amount included an upgrade of \$13,500.00 for stainless fixtures.

This project was advertised on March 20th and March 27th, 2019. This vote was approved on the condition that the County Council will approve allowing us to spend this amount of money from our 2019 funds.

With a discussion by the Board Members, some believe that we should still consider looking into a prefab type of shower house along with a traditional type of building. This needs to be cleared up prior to proceeding with the Shower House Project. The Board also gave Chairman Hollis the approval to sign the Contract for the Shelter House Project once it is completed.
